Dear Sir,

With ref. to our letter no.38, dt.8.01.2024, as per the HO instructions, the concession for the students is applied in the ecap.

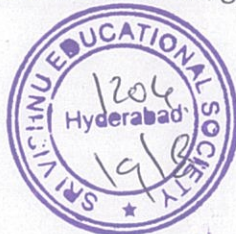


